GOSPEL JOHN 20:19-31

On the evening of that first day of the week, when the doors were locked, where the disciples were, for fear of the Jews, Jesus came and stood in their midst and said to them, "Peace be with you." When he had said this, he showed them his hands and his side. The disciples rejoiced when they saw the Lord. Jesus said to them again, "Peace be with you. As the Father has sent me, so I send you." And when he had said this, he breathed on them and said to them, "Receive the Holy Spirit. Whose sins you forgive are forgiven them, and whose sins you retain are retained."

Thomas, called Didymus, one of the Twelve, was not with them when Jesus came. So the other disciples said to him, "We have seen the Lord." But he said to them, "Unless I see the mark of the nails in his hands and put my finger into the nailmarks and put my hand into his side, I will not believe."

Now a week later his disciples were again inside and Thomas was with them. Jesus came, although the doors were locked, and stood in their midst and said, "Peace be with you." Then he said to Thomas, "Put your finger here and see my hands, and bring your hand and put it into my side, and do not be unbelieving, but believe." Thomas answered and said to him, "My Lord and my God!" Jesus said to him, "Have you come to believe because you have seen me? Blessed are those who have not seen and have believed."

Now, Jesus did many other signs in the presence of his disciples that are not written in this book. But these are written that you may come to believe that Jesus is the Christ, the Son of God, and that through this belief you may have life in his name.

SPIRITUAL ADOPTION PROGRAM - 8th Month

Your spiritually adopted baby is gaining weight at a steady pace. His heart has been beating since the 21st day and he has been fully formed since 8 weeks after conception. Pray that your baby's mother knows she can receive assistance from her area churches and crisis pregnancy centers whether her plans are to bring the baby home or place him for adoption. May your prayers continue to give her the grace she needs to seek whatever assistance she requires. Please pray daily the prayer of Bishop Fulton J. Sheen:

Jesus, Mary and Joseph, I love you very much. I beg you to spare the life of the unborn child that I have spiritually adopted who may be in danger of abortion. Amen.

PRAYER FOR SPIRITUAL COMMUNION

(during the time we cannot be present for Mass)

"My Jesus, I believe that You are present in the Most Holy Sacrament. I love You above all things, and I desire to receive You into my soul.

Since I cannot at this moment receive You sacramentally, come at least spiritually into my heart. I embrace You as if You are already there and unite myself wholly to You. Never permit me to be separated from you. Amen."

QUESTIONS TO SHARE

- 1) In the first reading from the Acts of the Apostles, we hear of an ideal Christian community in which communal life is loved to the fullest. During this time of the pandemic, many families have been living together 24 hours a day for many days. If tension and division has crept into your family, how might you help to bring the peace of Christ to this situation?
- 2) In the first letter from St. Peter, the apostle writes that at times the believer may have to suffer through trials, like God, tested by fire. When and in what occasions has your faith been tested?
- 3) Thomas believed only in the resurrection after seeing the risen Christ. Has there been a recent experience in your life that has either brought you to believe or confirmed your belief?
- 4) During the last month, how with your hands have you shown the love of Christ to others?

RELIGIOUS EDUCATION MINISTRY

Registration Postponed Until Further Notice

Our mission is to help parents share the Catholic faith with their children through several methods of learning. We hope to bring these young people to a deeper relationship with God from the teachings and love of Jesus Christ through the Holy Spirit.

Methods of learning:

- Traditional classroom: On Monday or Tuesday afternoons for Grades 1-5 and Monday or Tuesday evenings for Grades 6,7, and 8. This program runs from September until May.
 - Home Study - Grades 3,4,5 and 6. This is for parents who cannot bring their child to the Monday or Tuesday classroom settings. The parent would teach the child at home one lesson per week. We also ask that your child attend three activities throughout the school year.
 - Family Catechesis: - This program is offered to 1st and 2nd grade parents only. As a parent you will teach your child at home for three weeks with curriculum provided and then attend a class once a month in the evening with your child to reinforce what was taught at home. Both parent and child must attend this once a month class. Dates for once a month classes will be announced in July.
 - Special Disciples - This is a classroom setting for those with special needs. Our catechists are certified to teach children with special needs and we have a one on one approach with the children. This program runs every other Sunday during the 9am Mass from October until April. Please register for traditional classes as soon as possible as our Monday classes fill quickly.
- Tuition** : 1 child-\$100, 2 children-\$125 3+ children -\$150
