

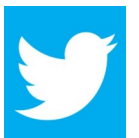

## Get Real

Dear Parishioners and Friends,

No one wants to suffer. We have words for people who enjoy their own suffering or the suffering of others. When Jesus says to his disciples that the Son of Man will suffer and die, Peter, who is always the first to speak up, says, "No, Lord! No way! No suffering for you!" Jesus replies rather harshly saying, in effect, "Get real, Peter."

We don't want to suffer, but suffering is real. Suffering is as real as the sun and the moon and the chair I am sitting on as I type this.

Jesus suffered. Fully human, Jesus is one with us in our suffering. That's what I see when I look at the crucifix. I see a God so filled with love with us He will unite Himself to us in everything ... even in what is most painful. This, to tell us, to show us, we are not alone in our suffering. We are loved through our suffering. Suffering is not the end. New life, deeper love, comes through suffering. This is why we can even dare to say suffering can be redemptive.

Because we are not alone, because we are loved, we do not have to despair when we suffer.

Recently, someone sent me the following in an email. I don't know the original author, so unfortunately I cannot give proper credit. But I think it is appropriate for today:

"Stop telling God how big your storm is. Instead, tell the storm how big your God is."

Your God is so big He is willing to suffer with us.

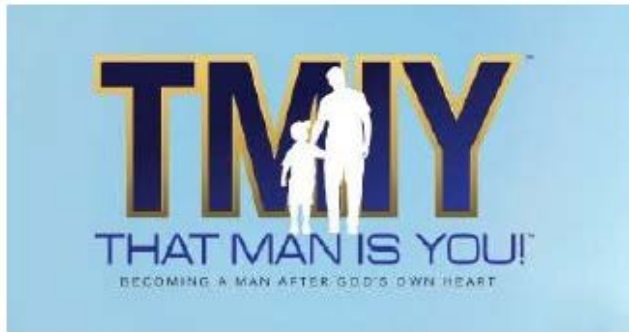

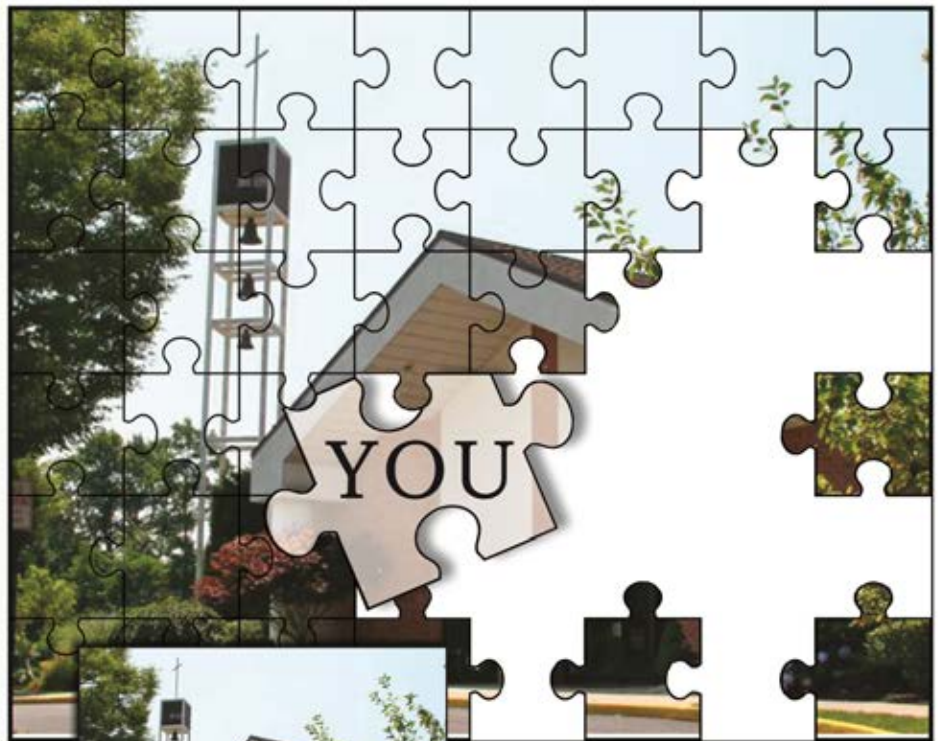
